#### Admission criteria

The academic levels of the MSc Programmes are highly advanced, and a thorough basic knowledge of one engineering or science discipline related to the MSc programme is required for admission. Admission is based on the following criteria.

#### Degree

Bachelor of Science in Engineering, Bachelor of Engineering or a Bachelor of Natural Science degree obtained at an internationally recognized university/higher education Institution (You can find general assessments for specific countries on the website of the Danish Ministry of Higher Education and Science. For further information, please follow this [link](#)). From September 2017 intake, the bachelor degree must be less than 10 years old, please contact [MScAdmissions@adm.dtu.dk](mailto:MScAdmissions@adm.dtu.dk) for questions.

	<p><b>Specific Requirements</b></p> <p>For details on specific requirements please refer to the entry requirements under each individual MSc programme of your choice. Please take a look at the <u><a href="#">Programme specifications</a></u> for further information.</p> <p><b>Grade Point Average</b></p> <p>Approximately 75 per cent of the maximum obtainable grade. This may vary depending on the grading system of the university awarding the Bachelor degree.</p> <p>Conditional admission with the possibility of additional study activity</p> <p>From the September 2017 intake, it is possible, in some cases to be conditionally admitted even if you lack up to 30 ECTS credits of qualifying courses. The qualifying courses must be completed before you start the MSc Engineering programme at DTU. In addition, you must complete your undergraduate BSc / B.Eng. before you start your MSc Engineering programme. The additional courses are not part of the MSc Engineering programme's total score of 120 ECTS, and tuition fees will be charged for these extra ECTS. This type of conditional admission on the basis of additional study activity is valid for one year only from the time of the admission offer. (e.g. if you have been conditionally admitted for the September 2018 intake, then the additional courses must be completed by September 2019). If you do not pass the courses within one year of the conditional admission offer, DTU will withdraw the conditional admission offer.</p> <p>International applicants - please note, that the possibility for conditional admission on the basis of additional study activity will only be applicable to you, if the course is being taught in English. Please note that the majority of the qualifying courses under this category are taught in Danish. In DTU's course base you can see, whether a specific course is taught in English or Danish.</p> <p><b>Admission Requirements</b></p> <p>The academic level of the MSc Eng programmes at DTU are highly advanced. The tuition fee for paying students enrolled in a DTU study programme is 7500 EUR per semester. Students may also choose to pay for an entire academic year all at once. Payment is made for the completion of a total of 120 credit points, with a normal workload of 30 credit points per semester. In the course of a semester, students have the right to complete as many activities offered within the programme (projects and/or courses) as they wish. Students enrolled in MSc programmes, who complete activities amounting to less than 30 credit points per semester, must also pay 7500 per semester. Students who have not completed their studies within the normal period of study have the right to complete their studies in the course of another academic year without paying tuition fees.</p> <p>Students who complete their studies in less than the normal number of semesters must pay tuition fees</p>

for the full number of semesters plus any traineeship period.

**Failure to meet the payment deadline**

Students who do not pay their tuition fees on time are withdrawn from the study administration system and will no longer be able to enrol for courses or examinations. When the outstanding fees have been paid, the student must contact the relevant office for further information.

The deadlines are May 15 for the September intake and December 1 for the February intake.</p> <p><b>Language requirements</b> When applying, you may have to prove your proficiency in either English or Danish, depending on the language of instruction used in the applied programme. The payment deadline is 14 days from the date we send the payment information to you.</p>

*Please note that you are exempted from paying if you:*

- hold a permanent residence permit
  - hold a temporary residence permit "with a view to/possibility of" being granted permanent residence in Denmark. Your permit must state: "mhp. varigt ophold" or "mmf. varigt ophold".
  - hold a residence permit pursuant to section 9m of the Danish Aliens Act as child of a parent who hold a residence permit pursuant to section 9a of the same act.
  - hold a permanent residence permit or a temporary permit "with a view to/possibility of" being granted permanent residence in one of the other Nordic countries (i.e. Norway, Sweden, Finland and Iceland).
  - hold a residence permit as a result of family reunification
  - hold a Danish bachelor's or professional bachelor's degree (180/240 ECTS, e.g. AP + PBA)
- This will not necessarily exempt you from paying a tuition fee.

#### *Degree Students*

Non-EU/EEA citizens are required to pay tuition. The tuition fee differs slightly from programme to programme. Check the section below about the prices to find the exact price of the Faculty you want to register for.

As a full degree student, you must pay the first semester's tuition before arrival.

If there are more qualified applicants than places available at a programme, there will be a selection process, according to programme-specific selection criteria.</p> <p>You can find specific entry requirements, selection criteria, and language requirements for each programme by viewing their individual admissions pages.</p> <p><b>Qualification for MSc</b> Your educational background at bachelor level is subject to an overall, concrete assessment, in order to establish whether you complete the minimum required academic prerequisites to study the master programme you have applied for.</p> <p>We expect you to have qualifications equivalent to a CBS bachelor degree: a relevant bachelor degree, issued by a nationally or regionally accredited, internationally recognised, research-based PhD-granting institution of higher education. A qualifying, relevant bachelor degree must include specific academic disciplines, defined for each master programme as a certain number of ECTS-points within specific areas of study.</p> <p>Your courses must have a specific academic content and level equivalent to bachelor level courses at CBS, and it is CBS Admissions who determine if a course can fulfil a certain specific entry requirement or not. We base our assessment on official course descriptions and study programme regulations.</p> <p>The specific entry requirements are covered by academic and research-oriented courses at bachelor level (for example, courses taken at CBS, Aarhus University, University of Copenhagen and similar institutions of higher education). If you completed vocational, practice-oriented courses (for example,</p>

courses as part of a Danish Professional bachelor's degree programme), their academic level and content will not be equivalent to CBS bachelor courses, and they are therefore unlikely to cover the specific entry requirements of master programmes at CBS.

The exact number of ECTS-points stated in the specific entry requirements must be covered. For example, 29 ECTS-points are not sufficient for covering a 30 ECTS-point requirement.

Admission is competitive and meeting the minimum qualifications and requirements does not ensure acceptance. The following are general guidelines.</p> <p><b>Qualifying degree</b> Admission to a Master's programme requires at minimum successful completion of a relevant and recognised university degree equivalent in level and content to a Danish Bachelor's degree. Specific requirements in regards to the content of the Bachelor's degree vary by programme. It may include specifications on accepted types of Bachelor's degrees relevant for the programme (for example, a Bachelor's degree in Sociology or Political Science), specific courses studied as part of the Bachelor's degree (for example, the equivalent of 15 ECTS of Macroeconomics), grade point average, language tests, etc. Generally, the University does not take supplementary courses into account when assessing entry qualifications for a Master's programme. Supplementary courses means individual courses or subjects studied but not included in the Bachelor's degree. If you are in doubt about the rules or have questions about the master's entry requirements, please contact the student guidance services for <a href="#">the Master's programme</a> you wish to apply for.</p> <p><b>Language requirements</b> Master's programmes taught in English do not require Danish language proficiency. However, they do have an English language proficiency requirement for admission. Applicants are required to document English language proficiency and should expect to provide documentation in the form of a language test, such as TOEFL or IELTS. Under certain circumstances, applicants can be exempt from taking a language test when other forms of documentation is available and accepted by the Faculty's admissions office. Exemptions from taking a language test are based on such information as citizenship, origin of entry exam, and in some cases origin of high school exam. The specific requirements vary from one programme to another, so please refer to the <a href="#">programme descriptions</a> for full and extensive information on which tests to take, what scores to obtain, and</p>

whether you may be exempt from taking a test.

**General conditions and regulations**

If you have previously studied at Master's degree, you ought to familiarize yourself with two important elements of the Danish Admission Order. These two rules are summarised on this page and are preconditions for applying for admission.

**Mandatory transfer of credit**

All applicants who have previously completed any courses or exams as part of an unfinished Master's programme at any university are required to disclose this information in the application. It is a requirement by Danish legislation, and the University of Copenhagen is obligated to use this information to evaluate whether applicants are eligible for credit transfer.

	<p><b>Tuition fees</b></p> <p>Applicants with citizenship from countries outside of the EU/EEA or Non-Nordic Countries must pay tuition fees. Applicants with a permanent residence permit in Denmark – or permit with a possibility of permanent residence in Denmark – are excepted from this rule.</p> <p>Tuition fees are in the range of EUR 10,000 to 17,000 per academic year, depending on the programme.</p> <p>Fees are paid either annually or biannually depending on the programme. Along with an offer of admission, students will receive information on how and when to pay tuition, as well as term of payment. For September admission, the first rate is due in April-May.</p> <p>Please consult the specific Master's degree programme for further information about its tuition fees <a href="https://studies.ku.dk/masters/programmes/">https://studies.ku.dk/masters/programmes/</a>.</p> <p><b>Exemptions from payment of application fee</b></p> <p>Please note that you are exempted from paying the application fee if you:</p> <ul style="list-style-type: none"> <li>• hold a permanent residence permit in Denmark (including Greenland and the Faroe Islands)</li> <li>• hold a temporary residence permit “with a view to” or “with the possibility of” permanent residency in Denmark (including Greenland and the Faroe Islands) and your permit states: “mhp. varigt ophold” or “mmf. varigt ophold”</li> <li>• hold a permanent residence permit in one of the other Nordic countries (Norway, Sweden, Finland and Iceland), cf. You will only have to pay the application fee once each application round regardless of whether you choose to apply for one, two or the maximum of three Master's degree programmes per application round.</p> <p>British citizens applying in 2021 will be asked to apply by the EU-date of March 1st 2021. When you enter the Application Portal, you may be met with a demand of proof for paid application fee – depending on the outcome of the current negotiations. The application portal opens January 16, 2021. 	<p><b>Language requirements</b></p> <p>All applicants without a legal claim to a Master's programmes offered in English at Aalborg University must prove that their English level is equivalent to level B (Danish level) in English with a minimum GPA of 3.0 in average or level A (Danish level) with a minimum GPA of 2.0 in average.</p> <p>Please note! When applying you must upload an official passed test score report or a receipt from the test centers confirming, you have signed up for a test.</p> <p>We do not accept IELTS and TOEFL tests that are more than 2 years old at the time of the application deadline. We do not accept the “TOEFL MyBest Scores”.</p> <p>If you hold a Bachelor’s degree from a Danish educational institution, and you took one of the mentioned tests less than two years before your bachelor admission with a score that meets our minimum requirements, it may be possible for you to be exempted from taking a new English test even if your test certificate is more than 2 years old. Please send us an email explaining your situation to hear more.</p> <p>You can prove your language proficiency by uploading one of the following tests.
