I am directed to refer to Federal Board of Revenue (FBR)'s Office Memorandum C.No.15(19)L&P/2019(Pt) dated 6th May, 2021 and to share this Ministry's observations/views to the queries raised therein, in the following manner:

Moreover, it is clarified that, in addition to complying with the conditions and procedural requirements contained in Appendix-E of the Import Policy Order in vogue, for import clearance of a car/vehicle imported under gift scheme, the importer/donce shall file attested copies of relevant arrival/departure pages of Pakistani Passport of the donor, attested by an authorized officer of the relevant Pakistani Mission abroad, clearly showing his 700 days stay abroad during

the last three years; and in case of dual national or foreign national of Indo-Pakistan origin having travel history on a foreign passport only, the attested copy of NICOP/POC and relevant arrival/departure pages of the Passport, attested by an authorized officer of the relevant Pakistani Mission aboard, showing 700 days stay outside of Pakistan during the last three years.
